Domeinspecifieke leerresultaten van de opleiding:

1. The master has a general knowledge of the basic principles of the subdomains of linguistics (phonology, syntax, semantics and pragmatics) and an advanced insight into how the subdomains are conceptualized within the chosen specialization.
 2. The master has insight into the dialectic between theory and analysis, and understands that observation and argumentation are partly determined by the theoretical perspective chosen.
 3. The master can read and understand analyses in other subdomains, and relate them to personal analyses conducted within their own domain of specialization.
 4. The master can read work from other theoretical traditions with insight, and can compare and evaluate the different methodological and theoretical principles.
 5. The master can motivate their own research practice (in one or more subdomains) relative to the theoretical and methodological diversity of contemporary linguistic research, and can enter into a dialogue with representatives of other traditions from their own frame of reference.
 6. The master is capable of making an original contribution to the international debate in at least one subdomain within their specialization and from their own theoretical vantage point.

7. The master can independently set up linguistic research, delineate the linguistic facts to be investigated, identify problems and formulate research questions in function of a specific research aim (e.g. fundamental, descriptive, comparative, sociovariational, computational, or dealing with translation or education) and choose the appropriate methodology.
8. The master can independently participate in the contemporary linguistic scientific debate and can situate their research within this debate in accordance with the requirements of the international scientific community.
9. The master can present their own research results in a structured way and support them with coherent argumentation, both in the spoken and written mode, and for specialists as well as in other communicative contexts.
10. The master has insight into the central role played by language in the psychosocial life of individuals, in society and in culture and science in general.
